

2016 Board of Directors Election

Nominations will be made at the February 12, 2016 Membership Meeting for four director positions for the 2016 -2018 term. The election will be held on Friday, March 11, 2016. To be a nominee, a prospective candidate must:

- Be a member in good standing as of February 2016
- Have been a member of the Lodge for at least two years and completed his probationary period
- Accept the nomination at the time it is presented at the February meeting. If he is unable to be present, he must have a representative deliver his written acceptance of the nomination at the meeting.
- Not be a purveyor to the Lodge
- Not work in a paid position for the Lodge or receive a salary or hourly wage from the Lodge, except for those positions on the Board that are salaried.

Those who accept nominations must submit a candidate's statement to Tony Povkovich, tjpovkovich@gmail.com, by **Monday, February 15, 2016** highlighting their history with the Lodge and why they wish to serve as a Roma Lodge Board member. These statements will be published in the March *Newsletter*.

The proposed By-Law changes to Article V, Section 6, Paragraph D and Article VIII, Section 1, Paragraph C voted on at the January 8th Membership Meeting both failed to obtain the two-thirds vote needed to pass. Both By-Laws stand as currently written in our By-Laws.

CURRENT BY-LAW: Article V, Section 6, Paragraph D.:

D. Members who have failed to meet their financial obligation to the Lodge by January 31st, and also failed to make special arrangements for payment of dues as provided in Paragraph C herein above, shall be dropped from membership. Members dropped for non-payment of dues shall be eligible to re-apply for membership upon payment of their past dues, the \$10.00 late payment penalty and a \$50.00 application fee. The decision to accept such member back into the Lodge will be made by the Board of Directors after consideration of a recommendation from the Membership Screening Committee. In the event the Board of Directors accepts such member back into the Lodge, the membership status of such member shall then reflect continuous membership, as though there were no gap in their term of membership as a result of this incident.

CURRENT BY-LAW: Article VIII, Section 1, Paragraph C.

C. No regular or special meeting of the Lodge shall be declared open unless a quorum is present. The presence of not less than 75 members in good standing shall constitute a quorum. When only 75 members are present at a regular or special meeting, a two-thirds vote is required in the matter of soliciting funds, except for the ordinary Lodge administration expenses.

ROMA LODGE MERIT SCHOLARSHIPS

What is the Scholarship?

Each year Roma Lodge makes scholarships available to children of Roma Lodge members who are in good standing as of January 31 of that calendar year. There is a \$4,000 scholarship, payable in \$1000 increments at the beginning of each of four academic years. In addition, the Lodge awards a maximum of three one-time \$500 scholarships to the second, third, and fourth place rated scholarship applicants. The scholarships can be applied to any full time course of study leading to a recognized baccalaureate degree in any accredited United States college or university of the recipient’s choice.

Who is Eligible?

All graduating high school seniors who are biological or adopted sons or daughters of Roma Lodge members in good standing as of January 31 of the calendar year are eligible to apply for the scholarship. It is necessary that the father of the recipient continue to be a member in good standing for the duration of the scholarship. Applicants must be graduating high school seniors. Candidates must be planning to pursue a full-time program of study (12 credits or more) in a college or university in the United States. Recipients of the Roma Lodge Merit Scholarships cannot receive any other scholarships offered through Roma Lodge.

Application Requirements

The applicants must:

- Complete a high school college preparatory course of study
- Demonstrate a commendable academic record which will qualify for admission to the college or university of their choice.
- Demonstrate positive citizenship and leadership qualities through participation in school and community activities.
- Show potential for higher academic success by achieving ACT or SAT scores acceptable to the college or university of their choice.
- Submit an official high school transcript
- Submit an ACT or SAT scores report form
- Submit two letters of recommendation

Financial need will not be considered during the selection process.



THE JOHN AND VLASTA KROES MERIT SCHOLARSHIP

What is the Scholarship?

The John and Vlasta Kroes Merit Scholarship was created in 2015 and is funded by Michael Kroes, a member of Roma Lodge, in memory of his parents. The scholarship awards \$1000 to a child of a Roma Lodge member who is in good standing as of January 31 of that calendar year. The scholarship can be applied to any course of study leading to a recognized baccalaureate degree in any accredited United States college or university of the recipient's choice.

Who is Eligible?

All graduating high school seniors, who are biological or adopted sons or daughters of Roma Lodge members, are eligible to apply for the scholarship. An applicant's father must be a member in good standing as of January 31st of the calendar year that application for the scholarship is made. The recipient's father must continue to be a member in good standing for the duration of the scholarship. Applicants must be planning to pursue a full-time program of study (12 credits or more) in a college or university in the United States. Recipients of the Kroes Scholarship cannot receive any other scholarships offered through Roma Lodge.

Application Requirements

An applicant must:

- Have maintained, at least, a cumulative 3.0 GPA (on a 4.0 scale) during his/her high school career and through the first semester of his/her high school senior year.
- Complete a high school college preparatory course of study
- Demonstrate a commendable academic record which will qualify for admission to the college or university of their choice
- Demonstrate positive citizenship and leadership qualities through participation in school and community activities.
- Show potential for higher academic success by achieving ACT or SAT scores acceptable to the college or university of their choice.
- Submit an official high school transcript
- Submit an ACT or SAT scores report form
- Submit two letters of recommendation

Financial need will not be considered during the selection process.



THE RUSSELL AND HELEN MISSURELI SCHOLARSHIP

What is the Scholarship: The Russell and Helen Missureli Scholarship was created to recognize the service they gave over many years to Roma Lodge, the church, and the community at large. The funds were donated by the family and friends of Russell and Helen Missureli on the occasion of Russell Missureli's ninetieth birthday. The scholarship awards \$1000 to a graduating high school senior who is the child or grandchild of a Roma Lodge member and who has been accepted as a full or part-time student in an associate degree or baccalaureate degree program in any accredited college or university in the United States. In addition to community service, scholastic achievement will also serve as the basis for selection of a recipient. The application, selection, and award process for the scholarship is administered by Roma Lodge.

Who is Eligible?: All graduating high school seniors who are the biological or adopted sons and daughters or grandchildren of Roma Lodge members in good standing as of January 31 of the calendar year are eligible to apply for the scholarship. It is necessary for the Roma Lodge member to continue to be a member for the duration of the scholarship academic year. Recipients of the Missureli Scholarship cannot receive any other scholarships offered through Roma Lodge.

Application Requirements: Applicants must demonstrate:

- Acceptance as a student in an associate degree or baccalaureate degree program.
- An exemplary record of community service as evidenced by a list of community, school, or church related activities.
- Academic achievement as evidenced by a full transcript of grades.
- Good character as evidenced by two letters of recommendation

OTHER SCHOLARSHIP SOURCES FOR ITALIAN-AMERICANS



Racine Italian Welfare Association (RIWA)

Throughout Roma Lodge's rich history, running the business side of the club has been undertaken by the Racine Italian Welfare Association (RIWA). This group was originally referred to as the "Building Committee", later the "Board of Trustees" and now the "RIWA Advisory Committee". In the past, these were elected positions. The elected members within the RIWA Committee would then select their president and officers. Currently, Roma Lodge's president serves as Chairman and he appoints the other committee members. The function of the RIWA Advisory Committee is to monitor and make recommendations on RIWA operations to the Roma Lodge Board of Directors.


